ORDER

- 1. The Principal Secretary to Govt., Department of Higher Education, Govt. of Kerala informed, vide letters read as second, that the Government have announced in the Budget speech 2020-21, for commencement of innovative and interdisciplinary courses in Affiliated Colleges. An Expert Committee was constituted with Prof. Sabu Thomas as the Chairman, to make recommendations on new programmes. It was also informed that Government have requested the Hon'ble Chancellor to extend the date of submission of applications for new courses till 31/08/2020 and requested University to submit separate proposals to the Hon'ble Chancellor for seeking extension of time.
- 2. Accordingly, the Hon'ble Chancellor was requested, vide letter read as fourth, for granting extension of last date for submission of application for starting innovative interdisciplinary programmes in affiliated colleges for the academic year 2020-21, upto 31.08.2020, as resolved by the Syndicate at its meeting held on 14.07.2020 vide paper read as third.
- 3. The Principal Secretary to Govt., Department of Higher Education, vide letter read as fifth, directed to call for applications from accredited aided and Govt. colleges and unaccredited aided colleges started by Scheduled Tribe Trusts, for commencement of innovative inter-disciplinary courses as suggested by the Committee constituted for the purpose.
- 4. The Principal Secretary to Governor, vide letter read as sixth, informed that if the Vice Chancellor intends to invite applications for starting new generation courses in affiliated colleges during the academic year 2020-21 on the basis of Government letter or otherwise, the Vice Chancellor may exercise first, the independent powers conferred on him as per Section 10(13) of the Calicut University Act, 1975. Thereafter, the Vice Chancellor may process and refer the eligible cases to the Hon'ble Chancellor for extension of the time period within which the Syndicate shall consider the applications for affiliation as per Section 56 (2) of the Calicut University Act, 1975. Also, in view of the above, the Vice Chancellor may take necessary action and keep that office informed about the action taken in the matter.
- 5. In compliance with the above direction, a notification was issued inviting applications from NAAC accredited Aided and Government Colleges and Aided Colleges started by Scheduled Caste and Community Trusts, even if unaccredited, within the jurisdiction of the University of Calicut, for starting additional innovative interdisciplinary programmes in arts and science stream for the Academic year 2020-21.
- 6. The Government, vide letter read as ninth, extended the date of receiving recommendations of the University on applications for commencing the programmes to 25.09.2020.
- 7. The applications received from colleges have been considered by the Syndicate and resolved, vide paper read as tenth, to forward recommendations for commencement of innovative interdisciplinary programmes in Govt./Aided Arts & Science Colleges to the Government and thus, recommendations of the University were forwarded to the Government, vide letters read as eleventh, for obtaining views of the Government as stipulated in Calicut University First Statutes, 1977.
- 8. Administrative Sanction was accorded by the Govt. of Kerala for starting innovative interdisciplinary programmes at Govt./Aided Arts & Science Colleges affiliated to University of Calicut during the academic year 2020-'21, vide G.O. read as thirteenth, based on the recommendations of the University.
- 9. As directed by the Hon'ble Chancellor, vide letter read as sixth, eligible applications along with recommendations were forwarded to the Hon'ble Chancellor vide letter read as fifteenth, for extending the period for consideration of applications by the Syndicate. As permission was granted by the Hon'ble Chancellor, vide letter read as sixteenth, the Syndicate considered the applications for starting innovative interdisciplinary programmes.
- 10. As decided by the Syndicate vide paper read as fourteenth, a meeting of Prinicpals of applicant colleges was held on 07.12.2020 and as per U.O. read as eighteenth, it has been ordered to grant provisional affiliation, in first phase, to the programmes for which approved syllabi are available in the University. Meanwhile, General & Academic- IV Branch and the Monitoring Committee constituted for observing the developments in implementation of decisions of the Syndicate in respect of starting

innovative interdisciplinary programmes and imparting suggestions, have informed that certain programmes for which approved syllabi are not available can be started with change in nomenclature, if the college concerned are willing to, and the matter was communicated to the colleges concerned.

- 11. Accordingly, the Principals of the Colleges have uploaded required documents such as affidavit in prescribed format and in stamp paper worth ₹200/- and challan receipt towards remittance of affiliation fee @₹2760/- (Rupees two thousand seven hundred and sixty only) for Govt. Colleges and ₹5515/- (Rupees five thousand five hundred and fifteen only) for Aided Colleges, for granting Provisional Affiliation to innovative interdisciplinary programmes for the academic year 2020-'21, in Centralized College Portal.
- 12. The Syndicate, at its meeting held on 30.01.2021 has resolved, vide item No.2021.130*, to grant provisional affiliation to the programmes having approved syllabi in the University, if the colleges concerned have uploaded the required documents in the Centralised College Portal and if not, to grant provisional affiliation to the programmes only when the colleges upload the documents in the Centralised College Portal.
- 13. Considering the matter in detail, sanction has been accorded by the Vice Chancellor, on 03/02/2021, to implement the aforesaid resolution of the Syndicate.
- 14. Govt. of Kerala have accorded administrative sanction again vide G.Os read as 22nd and 23rd, for starting new programmes in various Govt./Aided Arts & Science Colleges during the academic year 2020-'21.
- 15. Considering the above, the Hon'ble Chancellor was requested for extension of time for considering the aforesaid applications by the Syndicate, upto 31.03.2021, vide letter read as 24th. As per the notification read as 25th, the Hon'ble Chancellor has extended the period of considering the applications from the said Colleges, by the Syndicate, upto 31.03.2021.
- 16. In accordance with the decision of the Syndicate vide paper cited 21st, the Vice Chancellor has ordered to grant provisional affiliation to the programmes having approved syllabi in the University, if the Colleges concerned have uploaded required documents in the Centralized College Portal.
- 17. Thus provisional affiliation was granted to various innovative interdisciplinary programmes in various Govt./Aided Arts & Science colleges which have uploaded required documents in the Centralised College Portal, vide U.Os read as 26th to 32nd.
- 18. As the syllabus of the following programmes are approved by the University, the Colleges concerned have uploaded required documents in the Centralized College Portal.
- 19. The matter of granting provisional affiliation to the following programmes at various Govt./Aided Arts & Science Colleges was placed before the Syndicate, as per the orders of the Vice Chancellor on 15/09/2021. The Syndicate, at its meeting held on 22.09.2021 resolved to grant provisional affiliation to the following innovative interdisciplinary programmes, vide paper read as 33rd.
- 20. Considering the matter in detail, sanction has been accorded by the Vice Chancellor, on 29/09/2021, to implement the above resolution of the Syndicate.
- 21. Orders are, therefore, issued for granting provisional affiliation to new programmes in the following Govt./Aided Arts & Science Colleges affiliated to University of Calicut for the academic year 2020-'21 as given below.

22. Provisional affiliation granted is subject to the following terms and conditions:

- Affiliation granted is strictly provisional and only for the academic year 2020-21. College has to apply for Continuation of Provisional Affiliation for the ensuing academic year by remitting the fee fixed by the University. Admission to the next academic year shall be made only after obtaining prior permission from the University.
- As stipulated in G.O.(Ms)No.389/2020/HEDN dated 05.11.2020, no post creation shall be allowed for these courses till 2025. Classes should be run with guest faculties only.
- The management/college should abide by the provisions of the University Act, Statutes and Regulations of the University with regard to admission of students, collection of fee, etc.
- Selection and admission shall be made only on the basis of the rules and regulations of the University/Government and on the directions issued by the University/Government from time to time, failing which affiliation granted will automatically be cancelled.
- Conduct of University Examinations of any sort including that of SDE Examinations is compulsory and binding on all colleges affiliated to the University of Calicut.
- The Principal shall strictly follow the approved syllabi, which is available in the University website (www.uoc.ac.in) for selecting the complementary/common courses.
- In the light of the directions of the Supreme Court of India in WP(C) No. 656/1998, the institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent such instances, appropriate action including withdrawal of affiliation of the College will be initiated.

ORDER

- 1. Principals of various colleges submitted applications for additional affiliation to B.Voc. & M.Voc. programmes for the academic year 2020-21, along with letter of approval from UGC for conducting the programmes. The applications were received after the cut off date, as stipulated in Calicut University First Statutes, 1977, for receiving applications for starting new programmes.
- 2. Considering the matter, the Syndicate in its meeting held on 27.10.2020, resolved, vide reference cited 2nd, to address the Hon'ble Chancellor for extending the date of considering the applications by the Syndicate and accordingly the Hon'ble Chancellor was requested, vide reference cited 3rd, to issue a notification under the provisions envisaged in Section 56(2), Chapter VIII of the Calicut University Act, 1975, for the extension of time upto 31.12.2020 for consideration of the above applications for starting the new programmes for the academic year 2020-21, by the Syndicate.
- 3. Subsequently, the Hon'ble Chancellor issued Notification as cited 4^{th} , extending the period within which the Syndicate shall consider the aforesaid application upto 31.12.2020 in the academic year 2020-21 and the applications were considered by the Syndicate in its meeting held on 30.12.2020 and resolved to grant affiliation and permission to admit students from 2020-21 onwards, vide reference cited 5^{th} and 6^{th} .
- 4. Meanwhile the District Level Inspection Commissions(DLICs), conducted inspection in the applicant colleges and submitted reports recommending various B.Voc. and M.Voc. programmes for

the academic year 2020-21. The Syndicate considered the reports of inspection and resolved to approve the same, vide reference cited 7th.

- 5. A Committee was constituted vide U.O. cited 9th, for detailed study on conducting B.Voc. and M.Voc. programmes in affiliated colleges, as resolved by the Syndicate, vide reference cited 8th. In accordance with the recommendations of the Committee, which was approved by the Syndicate vide reference cited 10th, the Principals of the applicant colleges were informed the stream(aided or self-financing) of programmes applied for affiliation.
- 6. Recommendations of the University for starting B.Voc. and M.Voc. programmes during the academic year 2020-21 and NAAC score of the Colleges concerned were forwarded to Government vide reference cited 13th and 14th respectively, for ascertaining views of the Government as stipulated in Statute 9 (g) of Chapter 23, Calicut University First Statute, 1977.
- 7. Government of Kerala have accorded Administrative Sanction vide reference cited 15th, and No Objection Certificate was issued by the Government vide G.Os cited 16th to 19th, for starting B.Voc. & M.Voc. programmes in various colleges affiliated to University of Calicut under self-financing stream as detailed below, for the academic year 2020-21, subject to terms and conditions specified in aforesaid G.Os.
- 8. On receipt of administrative sanction and no objection certificates from Government, the Principals of colleges concerned submitted requests for granting affiliation to the programmes, along with affidavits in prescribed formats and in a stamp paper worth Rs. 200/- and challan receipts towards remittance of affiliation fee @ ₹.20,000/- for UG programmes and ₹.25,000/- for PG programmes for the year 2020-21.
- 9. Meanwhile the Principal, St. Mary's College, Thrissur requested, vide letter cited 20th, informed that the College has admitted students over and above the sanctioned intake to B.Voc and M.Voc Programmes prior to granting affiliation during the academic year 2020-21. An explanation had been sought from the Principal, vide letter cited 21st, in this regard and the Principal, vide letter cited 22nd, requested to allow the students admitted for 2020-21 batch.
- 10. Considering the above, Vice Chancellor has ordered (i) to place the matter of granting provisional affiliation to the B.Voc. and M.Voc. programmes under self-financing stream, for the academic year 2020-21 before the Syndicate and (ii) to bring the matter of irregular admission made in St. Mary's College, Thrissur, before the Syndicate.
- 11. Thus the whole matter was placed before the Syndicate, and the meeting of the Syndicate held on 29.11.2021 considererd the matter vide item No 2021.1130* & item No.2021.1141* and approved to grant provisional affiliation to B.Voc. & M.Voc. programmes under self-financing stream for which Government have accorded administrative sanction and issued no objection certificates for the academic year 2020-21 and approved the matter of admitting students over and above the sanctioned intake for B.Voc. and M.Voc programmes, prior to granting affiliation, in St. Mary's College, Thrissur, as a special case, as requested by the Principal.
- 12. Sanction was accorded by the Vice Chancellor on 08.12.2021 to implement the aforesaid resolutions of the Syndicate.
- 13. The following orders are, therefore, issued.
- (i) Provisional affiliation is granted to following programmes under self financing stream during the academic year 2020-21, in the colleges noted against each, with permission to start classes during the current academic year, i.e., 2020-21 itself.

- (ii) The admission made over and above the sanctioned intake for B.Voc. Applied Biotechnology and M.Voc. Applied Biotechnology programmes with an intake of 45 and 21 respectively in St. Mary's College, Thrissur, prior to granting affiliation, is approved only for 2020-21 admission as a special case.
- 14. Provisional affiliation granted is subject to the following terms and conditions:
 - Affiliation granted is strictly provisional and only for the academic year 2020-21. Colleges have
 to apply for continuation of provisional affiliation for the ensuing academic year by remitting the
 fee fixed by the University.
 - The educational agency/college shall abide by the conditions stipulated in No Objection Certificates issued by the Government, which is attached herewith, with regard to procedure of admission, collection of fees and other regulations, failing which affiliation granted will automatically be cancelled.
 - Admission to the next academic year shall be made only after obtaining prior permission from the University.
 - The conduct of University Examinations of any sort including that of SDE Examinations is compulsory and binding on all Colleges affiliated to the University of Calicut.
 - In the light of directions of Supreme Court of India in WP(C) No. 656/1998, the Institution shall take appropriate measures for prevention of ragging in any form. In case of failure to prevent such instances, appropriate action including withdrawal of affiliation of the College will be initiated.
- 15. The list of colleges which have been granted provisional affiliation will be forwarded to the office of the Controller of Examinations to ensure that examinations are not conducted in those colleges which do not have valid affiliation orders.
