Pareeksha Bhavan - Resolution of the Standing Committee of the Syndicate on examinations held on 02.08.2021 (Item No.AOD/2021/9/1) (Approved by the Vice Chancellor on 09.08.2021) to permit the candidates who are COVID positive or under quarantine to attend the examinations to be conducted and not to conduct the 'COVID - 19 special examinations' for the examinations scheduled hereafter - Implemented - Orders issued.

ORDER

As per the paper read (1) above, University had issued Notification permitting the candidates who were tested COVID positive at the time of examination, who were under quarantine and those who were pregnant, differently abled candidates and those who were having serious health issues and those who were stuck in foreign countries, for re-examination on production of valid certificate from the Government.

As per the paper read (2) above, it was ordered to conduct the COVID -19 special examinations immediately after the final semester examinations scheduled from 28.06.2021 onwards. Accordingly, vide paper read (3) above, notification inviting COVID-19 special examinations for the candidates who were tested Covid positive, who were under quarantine and those who were pregnant, differently abled candidates and those who were having serious health issues and those who were stuck in foreign countries at the time of the following examinations that were conducted during Covid - 19 Pandemic was issued directing them to produce relevant documents.

The Standing Committee on Examinations held on 02.08.2021, arising out of discussions, vide item No. AOD/2021/9/1 (Approved by the Vice Chancellor on 09.08.2021) considered that In the context of COVID patients being permitted to appear for examinations by other Universities and Boards of Examinations, it is resolved to extend this facility to the candidates of this University also who are COVID - 19 positive or under quarantine. This will be applicable in the case of all examinations that will be scheduled hereafter and in such cases 'COVID - 19 Special exams' will need not be conducted.

As per the paper read (5) above, the Controller of Examinations has accorded sanction to implement the above resolution of the Standing Committee of the Syndicate on Examinations.

The resolution of the Standing Committee of the Syndicate on examinations held on 02.08.2021 (Approved by the Vice Chancellor on 09.08.2021) "In the context of COVID patients being permitted to appear for examinations by other Universities and Boards of Examinations, to extend this facility to the candidates of this University also who are COVID - 19 positive or under quarantine. This will be applicable in the case of all examinations that will be scheduled hereafter and in such cases 'COVID - 19 Special exams' will need not be conducted vide item No. AOD/2021/9/1 is, therefore, implemented.

The following orders are, therefore, issued.

- 1. The candidates who are tested COVID positive or under quarantine at the time of examinations scheduled to be commenced from the date of this order are permitted to attend the examinations in compliance with the COVID protocol of Central/ State Government.
- 2. 'COVID 19 Special examinations' for the examinations scheduled to be commenced hereafter will not be invited / conducted.
- 3. The COVID 19 Special Examinations will be conducted for the examinations already notified vide paper read (3) / Examinations already started or over before the issuance of this Order.

Orders are issued accordingly.
