- 4) As per paper read as (4) above, the Syndicate at it's meeting held on 19-09-2019 vide item No.2019.857\* has considered the matter of implementation of G.O. referred as (3) above, a modification to the G.O cited (1), (the directions regarding the non participation of teachers in the valuation camps made applicable to Law Colleges also) and approved the same.
  - 5) Sanction has been accorded by the Vice-Chancellor to implement the resolution of the Syndicate.
- 6) In view of the above, the GOs directing the concerned authorities to take strict disciplinary action including of withholding of salary against the teachers of Govt/Aided Arts & Science/Law/Engineering/Polytechnic Colleges, those who have not participated in the valuation camp and behave irresponsibly, is therefore implemented.
