CRITERION I – CURRICULAR ASPECTS

1.1 - Curriculum Planning and Implementation

1.1.1 – Institution has the mechanism for well planned curriculum delivery and documentation. Explain in 500 words

The curriculum designed by the University of Calicut is followed by the institution for the programmes offered except for B.Voc programmes and Diploma Course, the latter offered by the Community College, where the faculty of the college contributes to syllabus framing. All the academic activities of the institution are charted as per the academic calendar prepared in tune with the affiliating university's academic schedule. The syllabus of all programmes is detailed in the college calendar and website for easy access to students. Formulation of a master timetable, department-wise action plan and semesterwise teaching plan is also assured. All the faculty maintain a teacher's diary as a record of their day-to-day teaching activities. To ascertain that the students have a sound grasp of the curriculum followed, various measures, starting from class-wise orientation on the programme specific and course outcomes, bridge course to new entrants, discipline-specific lectures/workshops/seminars, and routine participative classroom activities are undertaken earnestly. ICT integrated teaching, experience promoting educational ventures like field trips, study tours, industrial visits, internships, projects/dissertations, addon/certificate courses also contribute to the productive transfer of knowledge. The institution has a lucidly charted mechanism for assessing the effectiveness of curriculum delivery including periodic class tests, two internal examinations, assignments and seminars and timely feedback on the same. The class tutors are entrusted with identifying the slow and advanced learners and providing them with requisite guidance to upskill their academic performance. Tutorial and mentoring sessions, advanced and remedial coaching and peer-tutoring in addition to the adoption of initiatives like SSP, WWS, ASAP are extended to students for informed academic orientation. Monthly department meetings spearheaded by the Head, common staff meetings, PTA

meetings and stakeholders' feedback helps gauge the progress and effectiveness of curriculum delivery. Additionally, assessment on the same is carried out by the College Council, IQAC and Academic coordinators. The IQAC undertakes quality evaluation through internal and external academic audits, verification of teaching plan and teacher's diary and conduct of annual workshops/orientation for faculty to upgrade their professional acumen. The institution also ensures that suggestions for improvement/changes in curriculum are conveyed to the Board of Studies of Affiliating University through the faculty of the college representing the body.

1.4.2 – How the feedback obtained is being analyzed and utilized for overall development of the institution? (maximum 500 words)

Feedback Obtained

The institution abides by a coherent mechanism to collect and analyze stakeholders' feedback and effect constructive changes in areas required. Detailed feedback, specific to curriculum, teacher performance and other institutional provisions is taken from students, faculty, parents and alumnae from the end of IQAC. Feedback on the curriculum in terms of grooming students with employability skills are also obtained from the side of employers by the IQAC. A satisfaction survey of students and teachers on institutional provisions is conducted at the end of the academic year. The report on results generated from the statistical assessment of feedback is communicated to the Principal and from there to the Manager. Action taken report on the same is also filed. In addition to the same, the Heads of the departments ensure timely collection of student feedback on faculty performance, once in each semester and overall performance of the department, annually, based on the quality parameters suggested by the IQAC. The feedback thus collected are analyzed by the HoD, who shall maintain a report on the same for submission to the IQAC as and when required. Each faculty also collect personal feedback from students on their teaching once each semester. The department level PTA meeting is utilized to collect feedback and suggestions from parents on curriculum, teaching quality, the overall performance of the department, which are then taken up for detailed deliberation at the PTA Executive Committee meeting. Feedback on curriculum, infrastructural facilities, and institutional performance is also obtained from the alumnae during annual alumnae association meetings. The stakeholders' feedback serves as a beneficial tool to identify areas that require improvement and those that stand out in terms of quality.

As part of the proactive student-welfare measures, the institution has drawn a policy on mentoring to be abided by all faculty cum mentors of the institution. The mentor-mentee system adopted serves to extend guidance to students in their personal and academic growth. Each mentor is allotted a maximum of 16-20 students as mentees, with whom the mentor shall establish a purposeful and healthy relationship throughout their period of study in the institution. In addition to the hour specifically assigned per week for mentoring, mentors also have the liberty to meet with their mentees as and when the need arises. Ensuring the growth of mentees into self-sufficient individuals by keeping track of their progress in personal and academic domains, ensuring their mental wellbeing, helping them identify and channel their strengths productively and overcome weaknesses is of utmost priority of each mentor. Mentors maintain a Mentor's Diary to document each meeting with mentees and are also mandated to ascertain the confidentiality of the correspondence. The mentoring policy of the institution underscores the etiquette to be followed by a mentor in assisting the mentees assigned to their care. If the mentee is undergoing a severe predicament that is beyond the obligation of the mentor to advise/guide on, the same is brought to the immediate knowledge of authority concerned who shall ensure them proper channels of assistance and counselling.

2.5.2 - Reforms initiated on Continuous Internal Evaluation(CIE) system at the institutional level (250 words)

Continuous internal evaluation is ascertained at the institutional level to affirm consistency in the quality academic performance of students. The evaluation is based on student performance in the internal examinations, periodic class tests, timely submission/presentation of assignment, seminar/viva voce, and attendance/classroom performance. The academic calendar is strictly adhered to by the departments in furnishing the teaching plan, completing the syllabus and conducting the allied academic activities. Students are guaranteed easy access to educational resources and allowed adequate time

for study and revision. Identification of slow and advanced learners based on their academic performance is carried out by the class tutors and auxiliary measures including special classes, peer-tutoring, advanced and remedial coaching, and surprise tests are adopted to up-skill each category of learners. Regular monitoring of learners' responses to these supplementary methods of teaching and their progress is also undertaken as part of internal evaluation. Earnest efforts to address the concerns of academically underperforming students are taken by the tutor as well as the mentor. Two internal examinations per semester are conducted under the supervision of the Examination Committee to test students' comprehension of the subject and analytical/critical skills. Students who fail to attend either of the examinations owing to genuine reasons are allowed another chance with a different set of question paper. Prompt evaluation of answer scripts and publication of marks are also assured. As part of the assessment process, students are given informed feedback on their performance and progress in academics by the concerned faculty.

2.5.3 – Academic calendar prepared and adhered for conduct of Examination and other related matters (250 words)

The academic activities of the institution are conducted as per the institution's academic calendar formulated in tune with that of the affiliating university. Before the commencement of an academic year, the Academic Calendar Committee and IQAC, summoned by the principal, collaborates to codify the academic calendar that details the annual action plan of the institution. The calendar, thus prepared, is published in the college handbook and made available to both staff and students. Schedules for the conduct of internal and external examinations, commemorative days and events, holidays, publication of results, dates of commencement and closing of semesters, college closing and reopening etc are specified in the college calendar. The departments adhere to the prescribed schedule in charting department wise annual action plan and semester-wise teaching plan. The Examination Committee of the institution oversees the conduct of internal examinations by systematically charting the timetable and dates for preparation/submission of question papers, completion of evaluation and publication of mark list on the department notice board. Students are informed in advance about the schedule of examinations to allow adequate time for study and preparation. Departments comply with the schedule to execute timely completion of syllabus, allocate and evaluate assignments/seminars/practical as prescribed in the syllabus, and conduct auxiliary academic and non-academic activities as per the action plan.

The upkeep and utilization of all physical, academic and support facilities of the institution are ensured through the collective and systematic functioning of various committees constituted under the Heads of Planning, Building, Monitoring and Purchase. The budget allocation for meeting repair/maintenance/installation/renovation requirements are codified by the Finance Advisory Committee for final sanction from the Governing Body. The college bursar along with a team of efficient support staff oversees all sorts of maintenance work. A maintenance register is kept in the office for this purpose. Common physical facilities including auditorium, seminar and conference halls, open stage, Arts and Cultural Centre used for the conduct of academic and cultural programmes can be availed by departments/other institutional committees/cells following the submission of a pre-event registration form to IQAC and entering in the Events' Register at the Enquiry wing. The facilities are also extended for the conduct of distance education examinations and university valuation camps. Neighbouring institutions and recognized local bodies too can avail the infrastructural provisions with prior sanction. Library: The Library Advisory Committee governs the routine functioning of the library. The college library functions from 8.00 a.m. to 6.00 p.m. on weekdays and from 9.00 a.m. - 4.00 p.m. during weekends and the services are extended to the alumnae and public with a nominal registration fee. Each academic year, the HoDs submit the list of books/journals requirements to the library, which on sanction from the Principal is forwarded to the Purchase Committee. Annual stock verification of library books is ascertained. To ensure the return of books, 'no dues' from the library is mandatory for students before appearing for the end-semester examination. Separate reading corners and Networking Resource Centers are maintained for staff, students and research scholars. Classroom Classrooms are allotted to batches as per student strength. Spacious classrooms with CCTV surveillance facility are utilized for the conduct of combined classes and examinations. HoDs submit requirements for classroom furniture and other essentials in writing to the Principal who shall collectively process the same with the help of the Purchase Committee. Laboratory: The equipment and machinery in the laboratory are maintained by the lab in charge (s) and supervised by the Head of the concerned departments. Lab instructors in science departments maintain the stock register by manually verifying the items around the year. Log Registers are also maintained in labs. IT/ICT facilities Full-time technicians are employed for the maintenance of ICT equipment. Outsourcing is also done to maintain and repair IT infrastructures such as computers and internet facilities, including Wi-Fi and broadband. Sports Complex The College has a well-maintained indoor stadium, basketball court and a fitness centre. The fitness centre is open to both staff and students. Two rooms are allotted to the Sports Cell to hold meetings and stock sports equipment. The Physical Education Director of the institution regularly supervises the use of sports facilities and training sessions. College playground is made available for hosting university championships and for the conduct of various sports activities of neighbouring schools on request.

5.3.2 – Activity of Student Council & Expresentation of students on academic & Expresentative bodies/committees of the institution (maximum 500 words)

The student community, as the primary stakeholder, is accorded with the rightful agency through representation in prominent academic/administrative bodies of the institution. A democratically elected Student Union comprising of Chairperson, Vice-Chairperson, General Secretary, Joint Secretary, two Councillors to the Calicut University Union, Fine Arts Secretary, Student Editor, Departmental Associations' Secretaries, three representatives from each academic year of UG programmes and one from PG programmes, functions in the college to represent and work for the interests and welfare of student community and institution at large. The Student Union discharge their duties under the guidance of a staff advisor and periodically holds meetings to deliberate on the activities to be organized during the academic year. The Magazine Committee is entrusted with the release of the college magazine, which includes the varied creative, artistic and literary expressions of students as well as faculty. The body is also at the forefront in planning and executing community-centric social services and campaigns. The institution also has a Sports Cell with student representation in the position of General Captain of the college who is entrusted with coordinating the sports events of the college and coaching camps under the guidance of the Sports Cell Coordinator. A mass yoga awareness program in connection with International Yoga Day and the annual sports day Apocalypse 2020 of the college for the staff and students have been organized by the Sports Cell. Additionally, the autonomy of the student community is assured through representation in major college committees like SQAC, Anti-Ragging Cell, Student Grievance Redressal Cell, ICC, Women Cell, ALCUF, Library Committee, Discipline Committee and Hostel Council. Carmel College, since its birth in 1981, as a result of the foresightedness of CMC Udaya Province has shown a steady commitment to its core values and vision. Over the years, driven by the motto 'Light Love' the institution has worked tirelessly to "uplift the weak and downtrodden sections of society, especially the rural women, to liberate them from the shackles of bondage into a new world of 'light' and 'love'." The institution abides by its mission to work towards "the cause of empowering rural women with knowledge and inculcating in them the spirit of selfless love and compassion to spread peace in the society, living in harmony with nature and to illumine the world of eternity." Motivated by this urge to groom generations of perceptive young women through quality education and community engagement, the institution adopts a democratic, decentralized and participatory outlook in actualizing its mission. The apex decision-making body is the Board of Management while the governance of the institution comes under the purview of the Governing Body. The Governing Body is responsible for devising the institutional policies and procedures to be adhered to by all stakeholders. The Local Management Committee, Financial Advisory Committee and the College Council aid the Head of the institution in undertaking pertinent decisions relating to the routine affairs of the college. All the activities of the institution are spearheaded by the Principal through various committees constituted for the purpose. The College Council headed by the Principal and comprising of the HoDs, Librarian, and Office Superintendent along with the IQAC play a significant role in formulating and executing perspective plans and strategies for institutional enhancement. Productive and continuous dialogue with and involvement of all major stakeholders are carried

out in the meetings held at regular intervals with the Staff Association, PTA, Alumnae Association, and Student Union respectively. Each faculty is entrusted with the charge of various institutional committees and cells such as Examination Committee, Research Cell, UGC Cell, Career Guidance and Placement Cell, ICC, Anti-Ragging Cell, Grievance Redressal Cell, etc. and various clubs/forums in addition to duties deputed at department level such as tutorship, Club in-charge, event co-ordinator, and the like. Similarly, the institution has meticulously also designed the syllabus and all other required course details for all the certificate courses started during the year. Teaching and Learning	In order to ensure the operation of effective Teaching and learning process the institution ensures operational autonomy for the faculty to execute academic activities. The teachers are encouraged to plan the methods and tools to be used for a result-oriented process of curriculum delivery with starts as early as the department action plan and continues as support at

different stages, even upto the time they get placed in any revenue generating The students on the other hand are provided with opportunities to study their subjects and also explore the world of knowledge and information through a multidisciplinary outlook through the open courses and certificate courses offered by the various departments. The wifi connectivity has greatly aided the teachers and students to access necessary data and information and in turn further enhance the effectiveness of the teaching-learning process. Examination and Evaluation For the smooth conduct of examinations, periodic meetings of the exam committee and the timely monitoring by the IQAC , ensures a transparent and regular conduct of examinations both internal and external. The publishing of internal scores and their display on the noticeboard is done to ensure the same. The conduct of two internals is to ensure two equal opportunities for the students in order to be given a fair chance to be evaluated on the basis of their performance. The use of MIS for giving assignments, conducting internal exams etc. are also examples of the efforts made by the institution for the incorporation of e-governance in academic administration. The evaluation is done not only through internals, but also through class tests, seminar presentations, assignment submissions and overall performance of the students. Any difficulties or complaints in this regard are informed to the exam committee, students grievance redressal cell and the same is also discussed in the college council also if the need arises. Research and Development The institution provides encouragement to undertake minor/major research projects and MoUs with various institutions. The faculty members are also provided with financial assistance to attend workshops and seminars. The management funding for the conduct of

the same is also another noteworthy initiative of the institution to foster an attitude for research and development. The publication of a peer-reviewed journal for the faculty contributions and a journal for the

research contributions of the students also help to maintain the level of research and development initiatives. The institution in order to equip the Library, ICT and Physical Infrastructure / Instrumentation faculty and the students, organised orientation programmes, FDP, skill upgradation and training programmes, particularly in the use of ICT/LMS in collaboration with the IQAC for teaching and non-teaching staff. The library was upgraded with the addition of more books and also with the provision for better browsing and research facilities. Wi-Fi facility, ICT integrated teaching and a fully automated library with INFLIBNET-N-list soothes the teaching-learning process. The National Digital Library was also added to the list of resources that was being provided by the institution to the faculty and students, thus making the library more useful for the students. Usage of student-centric methods blended with ICT enabled teaching methods and the infrastructural support provided by the library, have greatly helped the students and faculty to improve their performance . The up gradation of the P.G. Department of Botany into a Research Centre and the resultant addition to lab and instrumentation is also an important initiative of the institution towards strategic development and deployment. The up gradation of the institution into a Wi-Fi campus is also a prominent initiative towards improving the productivity of the faculty and students. The institution is committed to Human Resource Management ensuring and improving the quality of human resource through the execution of various programmes, which include encouragement for participation in FDP, Faculty exchange programmes with other colleges and institutions etc. The IQAC of the college also monitors and conducts programmes from time to time that contribute towards the quality of the teaching staff. 6.4 – Financial Management and Resource Mobilization

6.4.1 – Institution conducts internal and external financial audits regularly (with in 100 words each)

Carmel College has in place a transparent and efficient financial management system to strategically pool monetary funds towards the institution's progressive initiatives. Since the institution is an aided one with both aided

and self-financing programmes, the funds mainly come from the Central or State Government. Financial support from the Management and student fees, constitute the other sources, all of which are subjected to both internal and external audits. At the end of a financial year, the Financial Advisory Committee meeting is convened to formulate a budget for the next academic year, taking into account, the financial requirements for purchase or maintenance put forward by the Heads of departments. The finalized blueprint of budget allocation is put before the Local Management Committee and Governing Body, and from there to the Board of Management for sanction of fund dispersal on time. A monthly report on expenses incurred is submitted by the Finance Administrator and countersigned by the Principal. On behalf of the Management, all monetary transactions are verified by the financial administrator of the college. Annual internal audit: The internal audit for all funds is carried out by CMC Udaya Educational Society through the Finance Office Secretary and the internal auditor of the Society appointed by the Manager of the institution. The auditor ensures that all payments are duly authorized, and verifies all financial transactions such as fee receipts, payment vouchers and other supporting financial documents. The external financial audit of Government funds and grants received by the institution follows a three-tier system. An external Chartered Accountant annually audits all the grants and funds sanctioned by the Central/State Government and furnishes a report issued with a Utilization Certificate. Auditor's observations and recommendations on amendments to be made are brought to the notice of the authorities concerned. The Government funds and all financial transactions are furthermore subjected to external audit by the Deputy Director of Collegiate Education. The Accountant General of Kerala also conducts periodic verification of all the Government accounts. All the documents including the receipts, bills and vouchers, asset registers, cash books and ledgers, tenders, quotations, payments statements of income and expenditure, scholarships and the utilization certificates of the institutional projects and those sponsored by other agencies, library registers, log books etc. are verified, and observations/suggestions are duly noted to be incorporated into the planning of effective utilization of funds. Cases of queries or objections are addressed and settled by the office of the College and Management. The external audit for Management accounts is delegated to a registered agency by the Management. Following thorough verification, annual financial statements and audit reports are prepared at the close of a financial year. Both internal and external audits reports are presented before the Local Management Committee, Governing Body and Board of Management for further deliberation. No serious audit objections have been encountered during the audits and all clarifications sought have been satisfactorily answered and validated by required documents.

With a majority of students hailing from economically strained backgrounds, the institution resolutely strives to lay a solid foundation to nurture their young mind and actualize their aspirations. It is at the heart of Camel College to, Foster academic growth among economically backward students augment the educational aspirations of the poor and the middle class Inspire the financially challenged to become selfreliant The Context Carmel, a college for women run by the Sisters of the Congregation of the Mother of Carmel, filled with the spirit of selfless love and compassion . The remote rural locale and the fact that the majority of the students are first-generation learners are major challenges for the institution. In this context, the Management has decided to give a hand to those students who aspire to attain education and become self-reliant. Born out of this loving intent is the programme "Give a Hand- To Lead, To Lift." The Practice The college gives both financial aid and emotional support to students coming from economically weak backgrounds to reach out to the horizons of excellence. They are given financial assistance in the form of fee concessions, scholarships and free field trips and study tours besides supplying books, uniforms and meals for free. The institution has also instituted cash awards to economically backward students for their meritorious achievements. To execute the same, the institution begins by inviting applications from students. The principal verifies the details of the application with the aid of the Heads of the Department. The visit of faculty members of each department to the homes of their students, generally on Fridays, and the meaningful interactions with their parents and family members provides an opportunity to understand their circumstances and extend seemly guidance. This is indeed beneficial in identifying the deserving student and those selected students are rewarded with incentives to assist them to come out in flying colours. The awards instituted by former faculty members, alumnae and well-wishers are given in the Annual College Day celebration to the needy students with good academic profile to pursue further studies. Substantial financial help is also provided to the deserving, meritorious and regular students from the Students Aid Fund. In addition, the college takes all effort to inform and sanction the monetary schemes for deserving students from the Management and government. The Chavara Euphrasia Scholarship and the Carmel Bright Scholarship instituted by the Management opens the door for the academic high achievers from low income families. Details regarding the scholarships are displayed on the college notice board and specified in the College Handbook. The loving embrace through the Faculty @ home programme has proved valuable for developing a cordial relationship between teachers and students. Students who hail from strained family backgrounds and encounter personal crises are identified by teachers and supported through mentoring and counselling sessions. A family counselling centre with a full-time professional counsellor functions in the college to help students get through distressing times. are an everyday reality for the families of several students, with some living in deplorable conditions and poor dwelling. In the light of financial exigencies the Abhayam scheme has been

utilized by the NSS unit of the college to initiate house construction for the neediest identified from among students. Departments also take initiative in raising funds to meet the medical expense of the ailing family member of students. The deluge of 2018 opened the dams of compassion among the Carmel fraternity. In the light of havoc wreaked by the flood upon families, both teachers and students spent nearly one month extending their helping hands and emotional support through house visits, cleaning flood-ravaged dwellings and providing monetary and material aid. 7.3 - Institutional Distinctiveness

7.3.1 – Provide the details of the performance of the institution in one area distinctive to its vision, priority and thrust in not more than 500 words

Carmel College has always strived to stay true to its vision and mission of empowering the young women of the locality through education, with the higher aim of bettering their social standing and society at large. Various institutional Committees, Cells, Forums, Student Union and departmental Associations, with student representation, spearhead several community enhancement initiatives. Mala, the small town, is primarily a layman's haven and Carmel College has always known where the people's heart lies. NSS units No. 2 and No. 89 of the campus are one of the vibrant subunits in the State. Each year, the units hold special camps in select locales of the institution's adopted villages or care homes, where students live with the community, interacting with them and engaging in activities to raise consciousness on health, environment, gender, and social issues. Free medical camps have been set up with the support of NGOs, hospitals and Banks for the benefit of the community. AIDS awareness campaigns funded by Kerala State AIDS Control Society, cancer detection and awareness campaign under OPPAM scheme, palliative care programme, awareness class on lifestyle diseases, health and hygiene, in particular on menstrual hygiene provided for the women of the community, are notable ventures. Skill development/entrepreneurship training programmes have also been initiated for the women community through training in the making of bags, umbrellas, LED serial bulbs/stars, paper pens, soap and other toiletries. The units have also been in the forefront to initiate two house constructions for the family of two students from the college under the AHAYAM project of Calicut University. The institution exemplifies a `green lifestyle' and is an

active advocate of nature conservation. Undertaking cleanliness drives, observance of sevanavaram, tree plantation drives, participation in initiatives like, Swachhta Hi Sevaare regular practices under the aegis of NCC and NSS units. Green initiatives including MutathoruVazha Project, tapioca cultivation, training in mushroom cultivation and vegetable gardening have been provided to the Kudumbasree units. The Carmel Extension Centre for Women facilitates training for the local women in tailoring, embroidery, handicrafts, ornament making, bookmaking and binding book, enabling them to secure a means of living. Training in mushroom cultivation, organic farming, preparation of karkidaka kanji, apiculture, vegetable gardening by the Department of Botany, training in making LED serial bulbs and daily use products like a paper pen, soap, detergents, carpet by Departments of Physics and Chemistry, extension classes to nearby schools on topics of social relevance including legal literacy, Open-Source Software, plastic waste disposal, reproductive health, communication skills, child abuse and child protection along with ayurvedic medical camp, health and socio-economic surveys, flood relief campaigns, activities in adopted villages under UBA and linkage with nursing homes and care centres for the differently-abled have been undertaken. At the heart of each of these endeavours is the desire to better the life of people in the community. Carmel College believes that no education is holistic, if it fails to connect the learners with the reality around and has stayed true to this conviction in all its practices.

8. Future Plans of Actions for Next Academic Year

In 2019-20, the institution made all possible efforts to recover from the losses and initiate development projects. Considering the ever-changing demands for and challenges of the various programmes and courses, the institution has planned to introduce new programmes and certificate courses that are more in tune with the demands of the industry and the employment market. The introduction of new programmes and courses also aims at providing the students with academic flexibility and a wider choice of subjects . This is more so important since the institution focuses on educating the rural women and providing them opportunities to access information, exchange of knowledge and employment gateways that are available to anybody in the most developed and advanced parts of the state or country. Encouraged by the support of the local community and the stakeholders, the institution plans to further the process of knowledge transfer through the various extension activities in the neighbourhood. The end of the academic 2019-20 witnessed the shutdown of educational institutions and there were government instructions to all to remain indoors. The sudden change in circumstances called for the strengthening of the administrative and educational machinery through the online mode. Faculty members are to be encouraged to create online content, e-resources and also videos of their classes so that the process of educating the young minds is not hindered. It is planned to introduce more courses through the MOODLE platform. Education and administration is also planned to be strengthened by making use of all other features of the MIS. The operation of the MIS is to be customised in such a manner that the academic performance and the levels of achievement of the students can be monitored and assessed on an the lines of Outcome Based Education (OBE). The institution also proposes to have academic as well as non-academic collaborations with other Higher Education Institutions (HEIs), in terms of faculty exchange, conduct of seminars, workshops etc. In collaboration with the government and non-governmental organisations, the institution aims at providing a platform where the expertise and discipline based know-how can be shared in the locale. This is sure to strengthen the co-existence of the two, i.e., the institution and the neighbourhood and also help attain the vision and mission of the institution. On the infrastructural front, the institution plans to make room for more classrooms and labs as per the growing requirements. Also, the institution is committed to further foster its green initiatives. The institution will be focussing more on spreading the message of environment and sustainability not only among the staff and students but also in the local community. On the strategic front, the institution is working towards the attainment of the autonomous status and improvement in the grades in the 4th cycle of the NAAC accreditation process.
